#### Chairman's Report for the Depden Annual Parish meeting

Last year was quite an uneventful we had our normal six Parish Council Meetings and two Policy and Planning Meetings. which dealt with 6 planning applications.

There were no changes in the composition of the council this year. Susan Boor has continued as our clerk and treasurer and I would like to thank Susan for the smooth running of council business. Pearl Sugden continued as our Internal auditor. Councillor Mark Leadbeater continued as Footpath Officer. Councillor Dennis Bibby continued as our representative on the Suffolk Association of Local Councils and Councillor Peter Payne continues to be the Tree Warden of the Parish.

We welcome Mary Evans to her first Depden Annual Parish Meeting as our new County Councillor and Derek Redhead, our Borough Councillor, to his 20<sup>th</sup> one! They have both regularly attend our Parish Council Meetings, despite their busy schedules, and we thank them for their support.

The council is very grateful to Angie Barnetson for continuing in the role of NW coordinator for Depden and ask all residents of the parish to support her in this role. Angie was also undertook the work to refurbish the village notice board, which now has two doors to avoid the need to balance the plastic cover on your head when attaching a notice!

The council remains concerned about speeding through the village, particularly across the green and this has been raised as a concern with the police at the Neighbourhood tasking meetings. We are currently exploring the potential for Vehicle Activated Signs to be installed at a suitable location and would look to share the cost with neighbouring parishes.

Our annual litter pick on March produced a bumper crop of 13 bags of litter, 1 wheel hub, a base of a traffic cone and 8 bags of dog mess. Thanks to Andy and Angie Barnetson, Susan Boor and Peter Payne for their participation, and urge more residents to get involved in future.

#### FOOPATH MEMBER REPORT

All the footpaths in the parish have been regularly walked and checked . There has been an unusual number of fallen trees due to the winter storms and these have been dealt with promptly by the landowner.

## Suffolk County Council

Thank you for your interest and support over the past year. I was very pleased to award funds from my locality budget for the refurbishment of the village sign. I realise that speeding is a major issue in the village and I have forwarded the clerk details of the new scheme to allow villages to buy and operate their own vehicle activate signs. I do hope this is something in which we can get several villages to join forces to share the cost.

One of the county council's biggest schemes is our energy to waste plant at Great Blakenham. I recently had a fascinating tour of the facility at which, from 1 December, all our black bin rubbish will be burned rather than being dumped in landfill. The incinerator will generate electricity to power about 30,000 homes. The facility uses the latest technology to dispose of the waste amazingly efficiently and in a highly environmentally friendly manner: all the residues are recycled; the steam generated by the process powers a turbine to produce the electricity, the gasses generated are cleaned before being emitted, and the residue from that process are recycled; some of the heat generated is going to be used to heat 17.5 hectares growing tomatoes and the remainder is likely to be used to run cooling units for a data store and a food processing plant.

The site, includes a wild life area and a visitor centre. From the autumn they will be running tours. To find out more see <u>www.suffolkefw.co.uk</u>

It also covers ways of re-using clothing and other textiles, as well as how to avoid food wastage. #### What to do in an emergency

I went to a training session recently to learn more about the key role councillors have in contributing to the council's actions in preparing for, responding to and recovering from such emergencies. The session was run by Neal Evans, SCC's Emergency Planning Officer. He took us through a discussion on how the county had fared in the storms and an exercise on responding to a plane crash over Suffolk.

He told us how in emergencies many people are not always aware of what to do or where to get help. For starters, many people are unaware that these days local councils do not hold stocks of sandbags to distribute to householders this because sandbags do not actually stop water getting into your house.

To help local people make sure they are prepared in future I can obtain copies of the Suffolk Joint Emergency Planning Unit's 'self-help emergency guidelines'. These are in the format of an information sheet which folds up into a nifty little pack with a magnet so that it can stick to your fridge. If you would like one for your fridge– please let me know.

Hi Susan,

Here is the annual crime report for Depden for the period 09/04/2013 – 08/04/2014. Ahead of tonight's annual parish meeting.

Since the last annual meeting held on 9<sup>th</sup> April 2013 there has been 1 crime of note in the area.

This was a burglary dwelling that occurred just yesterday, so as you can appreciate enquiries are still very much underway. The basic circumstances at this moment in time is at 14:57 on Monday 7<sup>th</sup> April an isolated property located on the outskirts of Depden just set back off of the A143 was broken into. It is not exactly clear what has been stolen yet, although it is believed to be jewellery and computers/electronic items. Police arrived on scene within seconds of the offenders leaving however no one was identified in the immediate area so we are now awaiting forensic examinations of the property and various other enquiries/investigations.

In comparison with the previous year from April 2012 – April 2013 there was just the one crime of note in the area also.

• This was a theft of front and rear number plates from a vehicle parked on the driveway of a property located on The Green.

Myself and PC Trish Sinclair are both on duty this evening and hope to attend in person. However if we are unable to make it please do not hesitate to forward any correspondence onto us for our attention.

Are there any updates as to the consideration of setting up Community Speed Watch in the village?

The SNT priority setting meeting was held on Tuesday 11<sup>th</sup> March. As a result our new priorities for the forthcoming period are as follows:

- 1) Targeting speeding motorists in the villages of Stradishall and Withersfield.
- 2) Addressing the parking issues at Wickhambrook primary school before and after school times and in Kedington on Friday evenings through education and enforcement.
- 3) Reducing the incidents of Burglary throughout the St Edmundsbury Rural South area.

The next SNT Priority setting meeting is scheduled for Tuesday 10<sup>th</sup> June 2014, 7pm at Bury Police Station.

The PCC, Tim Passmore, will be hosting a public meeting for the St Edmundsbury district on Wednesday 7<sup>th</sup> May 2014 at 6:30 pm at The Samuel Ward Academy, Chalkstone Way, Haverhill, CB9 0LD. Chief Constable, Douglas Paxton will also be in attendance at the meeting.

#### General information worth noting:

• There has been a recent growing trend of purse/wallet thefts from handbag/bags in town centres. The victims are predominantly elderly with the majority of offences taking place on market days. Various methods are being used such as: Taking purses/wallets visibly laying in the tops of bags, targeting shoppers in charity shops, and at supermarkets watching pin numbers being entered for payment and then following the victim into the car park and using distraction techniques to steal the bank card used. The suspects range in descriptions and possibly work in small groups or teams consisting of both males and females. In the past

they have also used children as a distraction cover. We are asking people to be increasingly aware when out and about shopping for this type of behaviour and to report any suspicious activity to us on 101.

• We have had increasing reports in Suffolk of a fraud scam currently ongoing nationwide where by the offender phones an elderly victim purporting to be a Police Officer investigating a fraud involving the victim's bank account. The offender persuades the victim to withdraw cash or send their credit card by handing to a taxi driver who will courier to the offender. The offender can be very plausible offering bogus numbers for the victim to call to confirm that a Police Officer has contacted them.

In response to this the constabulary now has a county wide operation namely Op Allow targeting this type of crime. If you hear of anyone that may have been subject to this type fraud offence please urge them to call Police and report it straight away.

- A black new shape Vauxhall Astra, no index mark, with 2 white male occupants in their 20's was seen at the scene of a daytime dwelling burglary in Fordham on Monday 24<sup>th</sup> March where an air rifle was stolen. The vehicle is suspected to be on false plates. If any vehicle matching this description is seen acting suspiciously please report it to us straight away.
- A red and black Toyota Hilux index mark L274 SCR was stolen from Kedington overnight on Wednesday 18<sup>th</sup> March. Any sightings of this vehicle please call 101.

On the back of this, in recent months, rural areas in the Babergh region have had a number of reported theft of Toyota Hilux's particularly those on older registration plates. These vehicles have then been typically used to commit further offences. If you see anything suspicious surrounding this type of crime then please report it on 101. If you would like any further security advice or information on how to protect your vehicles then please contact your local SNT.
