- 2. **DECLARATIONS OF PECUNIARY AND NON-PECUNIARY INTERESTS** Councillor Barnetson declared an interest in Item 12.

The Minutes, having been circulated before the Meeting, were taken as read and signed by the Chairman.

5. SPEED WATCH

The meeting was temporarily closed so Rod Gardiner from the Speed Watch Team could give a short presentation and that Mr & Mrs Golding could take part in the meeting.

Speed Watch is a partnership between Parish Councils, the Suffolk Constabulary and Suffolk County Council Road Safety. The scheme requires 6 volunteers who monitor the speed of vehicles from fixed sites and report on survey sheets.

If a vehicle is recorded exceeding the speed limit the owner is sent a letter stating that their vehicle has been recorded exceeding the speed limit. If further speeding is recorded then a second letter is sent stating that the details of the vehicle have been passed to the Safer Neighbourhood Team. If the vehicle is recorded speeding a third time then the details are passed to the Police who may take action. These letters stay on record a year. Mr Gardiner emphasised that Speed Watch is speed awareness not enforcement, only the Police can do that.

VAS signs are available and the Clerk agreed to discuss with Highways Department the possibility of 30 mph being painted on the road thorough The Green.

Angie Barnetson agreed to include an appeal for volunteers in her Neighbourhood Watch leaflet which is distributed to all the homes in Depden, The Clerk agreed to contact the Parish Clerk of the surrounding villages to ask if they would be interested in joining Depden in a Speed Watch scheme so that the cost can be shared.

6. BOROUGH COUNCILLOR REPORT

Councillor Redhead stated that the Inspector was on site at the Council to access Vision 2031 which includes the building of 1000 houses at Fornham All Saints. Shared services with Forest Heath District Council is causing concern. Still no news on the proposed enlargement, and the number of caravans at present, on Kelly's Meadow.

7. COUNTY COUNCILLOR REPORT

Councillor Evans reported that representatives of Suffolk Council had recently had a meeting with the Government Minister to improve Broadband Speed and Mobile Phone coverage in Suffolk. There has been an increase in Chimney fires and households are recommended to look at 'checkatrade.com' website to find a reputable tradesman.

8. **NEIGHBOURHOOD WATCH**

Angie Barnetson stated that people had been trying to sale gravel in Depden. Residents should phone 101 if they see suspicious behaviour and also phone her so she can report it to other residents.

9. SAFER NEIGHBOURHOOD REPORT

Councillor Barnetson reported that only 7 persons attend the meeting held on 3 December 2013. Priorities are speeding along the B1061 corridor and throughout Kedington, also parking problems in Kedington and burglaries throughput the rural south area. Next meeting Tuesday 11 March 2014.

Councillor Biddy reported that at the last meeting there had been a presentation of Council budgets. The next meeting will include a presentation about Solar Panels.

11. FOOTPATH REPORT

Councillor Leadbeater reported that the trees had been cleared.
