5. FOOTPATH REPORT

Councillor Leadbeater reported that the footpath sign on The Green has fallen over and the sign at the junction of footpath 4 and 1 is missing. The Clerk agreed to report this to Suffolk County Council. Also there is no sign on the verge of footpath nos. 4 and 3 which the Clerk agreed to discuss with Suffolk County Council. The Bridleway leading to Depden Lane, Chevington has been cleared.

Clive Pollington reported that representatives of St Edmundsbury Borough Council had meet with Government officers to discuss devolution. Devolution may enable the Council to develop land they own for profit, to pay for long term plans for transport and care in the community. Councillor Pollington reminded the meeting that he still has £500 from his locality budget to spend on community projects.

8.1 KELLYS MEADOW

Clive Pollington, with Mary Evans attended a meeting with Ian Gallin, John Griffiths, Ian Willis (owner), MP Mathew Hancock and Ian Parker (Advisor) to discuss Kellys Meadow. It appeared that the Highways Department of Suffolk County Council did not know that the enlargement was to go ahead and that they now agree that the land required, to solve the line of sight problem. is owed by Ian Willis. It is believed that at present there is 17 building on the site. Not clear what and when, enforcement to contain the number of vans, will be actioned.

The surface of the lay-by is being investigated. Suffolk Roadsafe Board has purchased a police speed caravan for use on rural roads and she will ask for it to be deployed in this area as soon as possible.

Reduction in the number of Fire Engines is planned but more Rapid Resource vehicles to be deployed. Theft of lead from churches is to be discussed at a meeting with the Police and Crime Commissioner.
