5. NEIGHOURHOOD WATCH REPORT

Angie Barnetson stated that burglaries have been reported in the surrounding area. A list of forthcoming events had been circulated. St Edmundsbury South Safer Neighbourhood Team has moved from Clare to Haverhill Police Station but will have a drop-in session at Clare Fire Station every Tuesday from 10am to midday.

8. FOOTPATH REPORT

Councillor Leadbeater reports that the footpath no. 4 had been marked in the wrong place. The landowner Councillor Rabett said the field crop would soon be cut.

10. FURTHER POLICE REPORT

PC Marshall asked all victims of crimes to report them as all crimes should be recorded. Ex-prisoners selling household goods known as 'Nottingham Knockers' have been active in the area. Request to report inappropriate sales pitch to phone no. 0845 4040506. At present there is no change in the number of police personnel in the South Suffolk area. PC Marshall left leaflets about Police Connect.

11. COUNTY COUNCILLOR'S REPORT

Councillor Evans reported that she had had a meeting with Tom Nunn of Suffolk Highways and a Traffic Consultant regarding the speeding problem on the A143. (No one else was invited to the meeting to save time and cost of the Consultant). The Highways are assessing placing Chevron Signs on the bends near the Elm Farm turning but are against gateway signs for villages feeling they do not slow traffic down. Extra brackets for the VAS Signs have been requested, by villages taking part in the scheme, at a cost of £70.

Anglian Water are responsible for the hole in the road from Depden to Hargrave. There is to be a consultation by the Fire Service regarding retained Firemen. The County Council is considering passing the cost of the Brown Bins to District Councils which may result in a cost to householders.

12. BOROUGH COUNCILLOR'S REPORT

Councillor Pollington stated that central government is planning to pass down more powers to local councils. Crimes figures in the area are down. Locality grants are available again this year for local projects.

No change at Kelly's Meadow as the highway problem has not yet been resolved. Councillors Evans and Pollington agreed to discuss with the Borough Council enforcement of current planning consent.

Councillor Arnold reported that the chipping on the lay-by on the A143 create a lot of dust when the weather is dry also the lay-by is being used for overnight parking.

13. BANK ACCOUNT SIGNATORY

The forms were signed so that Councillor Barnetson could become a signatory of the bank account of the parish council in place of former Councillor John Walladge.

Her report was discussed and it was decided to ask that the sign from the Hargrave/Wickhambrook Road to be located closer to 'Hillside' and the sign from the A143 to be located closer to Church End. As the suggested location of the signs were to be placed on existing poles the new locations may result in a cost of £150 per pole plus £70 per bracket which in principle the meeting agreed to. The Clerk agreed to contact Hen Abbott.
