- 3. MINUTES OF THE MEETING HELD 13 JULY 2016

8.1 INSURANCE

Hargrave Parish Council have proposed that they put the VAS Sign, we share with themselves and Ousden, on their Asset Register at £1 and pay the insurance for the VAS Sign for all three villages. They would not pass on any of the cost but Depden and Ousden must agree they would pay the £100 excess if the any claim is made when the sign is displayed in those villages. The Councillors agreed to this arrangement and Councillor Leadbeater signed the form from Hargrave Parish Council.

It was reported that paint had been sprayed on the Sign when installed at Church End and that Councillor Leadbeater and the Clerk spent nearly 2 hours cleaning it.

The Clerk reported that the external audit had been completed and there were no issues identified.

11. BOROUGH COUNCILLOR'S REPORT

Clive Pollngton reported that the Hub had not yet been approved by the Planning Dept. and devolution is still in progress. He has had a meeting with Ian Gallin concerning Kellys Meadow where the management plan and enforcement of the number of vans were discussed. Councillor Pollington is awaiting written confirmation of the matters discussed at this meeting.

12. COUNTY COUNCILLOR'S REPORT

Mary Evans reported that 'onesuffolk' website for local Councils, which is free, is to be moved to Community Action Suffolk where a charge of £50 per year per parish will be made. This move has come about because Suffolk County Council has withdrawn its grant.

There has been a change of protocol concerning speed limit changes. Councillor Ebbens agreed to obtain details from the Highways Department.

Suffolk students achieved good GCSE results including those seeking asylum and 82% of schools are good or outstanding. Children in care who took GCSE's have received a voucher for cinema etc. as a 'well done' present.

13. SPEEDING

13.1 ELM FARM TURNING

Councillor Ebbens reported that there has been near misses and an accident at the Farm Shop. The grass has been cut back at the junction.

13.2 HALL CLOSE JUNCTION WITH THE GREEN

The meeting was closed to allow Mr & Mrs Rolfe to discuss their concerning about the junction at Hall Close and vehicles driving over their grass verge.

Problems have been due to speed and more lorries using the Green. Concern was also expressed about where the School Bus turns and it was agreed that the Clerk will write to Neals Transport expressing the concerns of the Parish Council. It was agreed that the Clerk also write a letter to 'Grey Tops' expressing concern about their hedge which obscures the 'line of sight' at the bend.

Councillor Evans agreed to contact the Highways Department to discuss road markings and signs.

14. MILLENNIUM FARM TRUST

The meeting concluded closed so that Tim Freathy could give a presentation of the Millennium Farm Trust, a charity care farm which provides occupation for people with learning difficulties and disabilities. Councillor Leadbeater took no part in the following discussion.

The Farm Trust has been at Rookery Farm, Depden for 2 years and is open 3 days a week. Many of the people have mobility issues and the Trust are making a bid for lottery funding for access paths and a poly tunnel. Mr Freathy is requesting support from community organisations and it was agreed that the Clerk should write a letter of support to include that the Trust cuts the grass for the Parish Council.
