#### 6. COUNTY COUNCILLOR'S REPORT

Councillor Evans reported that a Police Community Officer for the area had been appointed. The Council has a new leader, Mathew Hicks, and Councillor Evans is Deputy Leader and Cabinet Member for Highways. She hoped to see greater use of new technology and improved communication between departments. The Environment Department had issued new rules concerning the cleaning of gullies where clean water had to be left in the gully which will involve additional expense. and Bury St Edmunds to the West Suffolk Hospital. This service is being funded by Suffolk County Council and the Hospital.

The Hardstanding at the new bus stop on the A143 is still in hand.

## 7. BOROUGH COUNCILLOR'S REPORT

Agreement has been reached concerning the use of the land to improve the 'line of sight' for Kellys Meadow and is just awaiting completion. A grant of £245k has been obtained to assist with rough sleepers. The development of the old Post Office in Bury St Edmunds had received good comments.
