Councillor Bennett reported that The Fire Service Response for Suffolk is to be returned to Suffolk. Budget costs are under pressure especially adult care. Regarding the siting of the speed signs by Anglian Water they have the legal right to decide on the site of temporary speed signs. She requested that pot holes should still be reported and funding is available for repairs to road signs.

Councillor Ebbens asked about the overgrown hedge opposite the Elms Farm turning The Chairman requested a site meeting with a representative of the Highways Department. The entrance to the turning is being used as a turning place on the A143.
