6. ANGLIAN WATER NEW PIPE LINE AND COMPOUND

Councillor Read reported that the pipeline has been marked and the compound is being built. The route across the Old Airfield is open with 'what three words' in place. There are 30 mph signs are on the A143 from Chedburgh to Depden. The compound has a two year life. The roads are being swept and traffic movement signs are also in place. The archaeological dig is still in process. The laying of the pipeline should start in 2 weeks.

6.1 BRIDLEWAY/BYWAY FROM DEPDEN GREEN TO CHEVINGTON

This footpath has been temporarily closed due of the pipeline crossing. There has been a complaint made by a resident because a culvert is blocked and the ditch has eroded. The Rights of Way Officer has state that it is for the Parish Council to contact the land owner, Mr Wiseman who lives in Hargrave. The Parish Clerk agreed to contact Hargrave Parish Council.

Councillor Read stated that it was well presented survey and a good indication of the views of the residents. Councillor Leadbeater agreed to put the presentation on the website and to arrange a flyer to be distributed in the next Benefice Newsletter to inform residents of the results of the survey. As the majority of the residents, who completed the survey, were not in favour of further development in the village a Neighbourhood Plan would be difficult.

A grant of £500 had been agreed from West Suffolk Councillor's Locality Budget and will be sent direct to the Care Farm for the Case. The Parish Council had also been offered £300 from the locality budget of the Suffolk County Councillor. It was agreed to request this as the cost of the installation has not yet been fully covered.
